IN 2010, MORE THAN 30 RESEARCH GRANTS, EXCEEDING 2.5 MILLION DOLLARS IN RESEARCH FUNDS, WERE AWARDED TO SCIENTISTS AROUND THE WORLD. THESE GRANTS COVERED A WIDE RANGE OF RESEARCH. SOME OF THE GRANTS ADDRESS THE NEED TO FURTHER UNDERSTAND THE BASIC SCIENCE, SUCH AS THE ROLE OF FRATAXIN AND CELLULAR PATHWAYS IMPLICATED IN FA.
